IFGL Pensions has undertaken a Target Market and Fair Value Assessment as the manufacturer of the Inspire SIPP product. This document is designed to present the outcome of our Target Market and Fair Value Assessment, carried out in line with New Consumer Duty, in April 2024. The Duty introduced new rules and guidance to ensure good outcomes for retail customers. One of the key areas of the Duty is to ensure that products and services provide a target market and fair value with a reasonable relationship between the price consumers pay, and the benefit they receive.

The Inspire Self-Invested Personal Pension (SIPP) is a type of personal pension plan that permits customers to invest in a wide range of investments for the purposes of building a retirement fund within a tax-efficient pension wrapper.

Assessment	Detail
Details of Fair Value Assessment	The Assessment covered the four outcomes of the Consumer Duty: 1) products and services, 2) price and value, 3) consumer understanding, and 4) consumer support.
	Our analysis included:
	• Fees and Charges – a review of the costs incurred by our customers to ensure they represent fair value, taking into account the features and benefits of this product; scenario testing based upon our target market; margin level assessment; competitor analysis, as well as the costs associated with financial advice for customers engaging with this product.
	Customer Insight and Feedback - including complaints analysis.
	 Target Market Distribution Strategy – considering whether the Inspire SIPP meets the needs, characteristics and objectives of the target market, any risks of the product to the target market and vulnerable customers, and adviser feedback.
	 Communications – testing of our customer communications to help ensure our customers receive communications which are clear and understandable.
	 Service Delivery – ensuring we can provide a service level in line with the expectations of our customers, and aid in avoiding foreseeable harms.
Date of Fair Value Assessment	This review was completed in April 2024.
Outcome of Fair Value Assessment	Considering the FCA rules and guidance, the Inspire SIPP product provides fair value to retail customers within the target market.
